ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, Neelam College of Education, 1249/999, Vill - Jim Jima, Manja, Post - Dul, Tehsil - Joginder Nagar, Distt. -Mandi, Himachal Pradesh - 176120, has submitted an application to the Northern Regional Committee of NCTE for grant of recognition for starting B.Ed. Course of one years duration with an annual intake of 100 (One Hundred only) students on 29.10.2008.

AND WHEREAS on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee is satisfied that the institution/society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary Teacher Education Programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the Programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

NOVY, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to Neelam College of Education, 1249/999, Vill - Jim Jima, Manja, Post - Dul, Tehsil - Joginder Nagar, Distt. - Mandi, Himachal Pradesh - 176120 for conducting B.Ed. Course of Secondary (level) of one year duration with an annual intake of 100 (One Hundred Only) students trom the academic session 2009-2010 under clause 7(11) or NCTE Regulation, 2007 notified on 10-12-2007.

- I. Order for recognition/permission will operate for 2009-2010 only if requirement of 180 teaching days in the session is fulfilled as per calendar of the University/Affiliating Bouy.
- The admissions of students shall be made only after affiliation by the examining body before the commencement of the academic session and the admission of students shall be completed well before the cut off date prescribed by the examining body for the academic session 2009-2010 failing which the recognition will be effective from the academic session following the date of withdrawal of ban, by NCTE, on further grant of recognition of B.Ed. course in the State of Himachal Pradesh.
- III. The institution shall, within one month of the receipt of recognition order, convert the endowment fund and reserve fund accounts into joint accounts to be operated along-with an officer of the Novemern Regional Committee.
- The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- V. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE Regulations, 2007 notified on 10.12.2007.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed under relevant norms and standards of NCTE for other regulatory bodies like UGC, the State Government etc wherever applicable.

The institution shall submit to the Regional Committee a Self-Approximal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant
